HOW TO SELF-CERTIFY THE PROPERTY

- i. Open your internet browser and open the website: <u>https://property.ulbharyana.gov.in/</u>
- ii. Now login on the portal.
- iii. After you login, the system will show the properties linked with the Mobile Number/email-id through which the user has logged-in.

Under each section, the citizen needs to certify that whether the data shown in the section is correct or Not. In case all details are correct, select <u>Yes</u> Radio button in each section.

In case all details are correct and Yes radio button is selected.

- Now, system will prompt you to enter Family (Parivar Pehchan Patra) Id. Enter your Family ID. An OTP will be sent on your mobile number registered with the Family -id. Enter OTP and click on Verify Details button. Your property will be self-certified.
- b. If you do not have Family id, Enter Aadhar Number. An OTP will be sent on your mobile number registered with the Aadhar Number. Enter OTP and click on **Verify Details** button. Your property will be self-certified.

- c. If you do not have Aadhar number also, click on No. Now system will ask you to certify that you do not have Family-id and Aadhar Number.
- d. Now an OTP will be sent on the mobile number registered with your property. Enter OTP and click on **Verify Details**. Your property will be self-certified.
